THEMATIC JURORS SEMINAR-SOFIA '89

This paper submitted by Dr. Moroli, intends to cover some points on the basis of the experience with the new regulations and the related Guidelines in the exhibitions organised in the last 12 months.

1. Thematic Elements

1.1 PLAN

The Plan page has to be considered only as the summary representation of the Plan, which has to be visible as the structure of the exhibit. The combination of major sub-divisions, duly listed in the plan page, and more detailed sub-divisions, at page level, makes the plan understood in all its depth and comprehensiveness.

Furthermore, in addition to the major prerequisites of the plan (logical, correct, balanced), its originality (that means personal elaboration of the plan) should be taken into consideration.

1.2 SIZE

Considering that Jurors must evaluate only what is shown and that in recent exhibitions most participations were allocated a fixed (and smaller) number of frames, this criterian should be intended as reflecting the "scope" of the elaboration.

The scope is evaluated considering the one of the exhibit with the potential one that can be achieved through a very comprehensive and complete plan and a thorough and deep development.

The number of pages declared in the plan page is requested only as an help to understand the relation between the selected pages and those available according to the general design of the plan and its implementation in the collection.

1.3 DEVELOPEMENT

Originality should be considered mainly in the sense of personal research as made visible through the development of the material in order to describle the theme. It should be also remembered that original the nes are no longer such when covered by an increasing number of exhibits and/or studies published in the philatelic press.

Special attention should be paid to the sequence of the items in the page and to the related description, which sometimes is more suitable for an auction catalogue than for a thematic exhibit.

2. Philatelic Elements

2.1 PHILATELIC KNOWLEDGE

Ir is important to check if the exhibit presents the widest selection of items by type, period and issuing country within the possibilities of the theme. This selection should be well balanced, without any unjustified preference according to type, period and issuing country of the items.

Border line items which belong only to a specific national philatelic culture (e.g. U.S. patriotic covers) and on this basis are accepted in exhibits shown at national level, should be tolerated, unless their quantity is unjustified.

Special appreciation should be given to items which have not yet been researched for that theme, or which have a thematic qualification which is not immediately obvious and needs to be discovered by the exhibitor.

2.2 CONDITION AND RARITY

Rarity of items which are not related to the theme should not influence the evaluation of this criterion.

3. General Consideration

3.1 POSITIVE JUDGING

The Jurors has to evaluate the exhibit as global entity.

Every criterion should be evaluated in the "positive" way that is making the average

of the positive and negative aspects related to the same criterian.

Points should be given starting from 'zero' onwards, and not deducting from the maximum allowed for the specific criterion.

The evaluation should not be influenced by special situations tor example: few outstanding pieces or a major error), which have to be reflected in the average process. In particular rairity should be evaluated on the basis of what is exhibited, not on what is missing.

3.2 TEAM JUDGING

Each Jury is composed of members with different philatelic and cultural background, knowledgeable in different themes and conversant in different languages. Also the individual judging capability may be effected by the level and the thematic coverage of the national

collections and the frequency in judging in the home country.

In most occasions the combination of these experiences brings a very high added value to the judging activities. Any way a Juror should be very cautious when evaluating those exhibits which are more difficult for him, because of language, and/or theme, and/or material. Jurors from other thematic teams (or other classes) should be asked for support whenever a team does not feel completely comfortable with the judgement of a specific exhibit.

Whenever thematic class is judged by two or more teams, they should exchange their results before posting them and reach a common agreement at least on the highest levels of medal. A common complete review of the exhibits according to the ranking by medal has proven to be very useful in order to achieve a more balanced judgement.

USPS Issues First Picture Postal Cards:

THE WHITE HOUSE JEFERSON MEMORIAL CARDS DEBUT AT WORLD STAMP EXPO.
